Large Party Policy

Member information.....

Large parties (50 or more guests &/or catered event) are allowed on the Association beach & park property **ONLY** in the months of May, June or September (after Labor Day weekend) and October. In order to arrange a large party the event must be for a member/ property owner or their immediate family.

Before a date can be assigned:

Our application & policy forms must be completed and signed by the member/ property owner and all fees and deposits paid and received by LTPA before the date requested can be confirmed. The fee will be \$1,000.00 plus a refundable \$500.00 security deposit. Confirmation of your large party "date" will be sent to you by mail &/or E-Mail upon approval.

On site use:

The on site use of the property is a non-exclusive use of the beach area & piers. Your area needs will be designated as your party site but our Association rules will not permit restricting members from the use of the beach, piers, walkways, or restrooms. The large barbeque pit at the north end of the park can be reserved exclusively for your party if needed. At no time can we allow any guest boats to park on the beach, use unauthorized buoys, or tie up to our piers for more than 15 minutes.

Minors are not allowed to drink alcoholic beverages on the premises.

The grass areas are for the quiet enjoyment of guests only. Please no baseball, football, soccer, Frisbee play in that area. Tables, chairs for dinner, dance floor, tents for shelter must be located off the grass area.

Music may be played by various sound systems or a D-jay during afternoon and early evening hours only. (2:00 PM to 8:00 PM). The sound must be reasonable and cannot disturb the neighborhood.

Parking for guests is off site. The Association makes no commitment to provide adequate parking in the area. Guests may access the park through the main gate. The member/ sponsor of the large party is to provide the beach staff with a typed list of all guests names prior to the party and have someone responsible for letting your guests into the park stationed at the main gate. A vendors list will also be required. Vendors may make arrangements to access the park through the gates at the north or south ends of the park.

The large party site cleanup is the responsibility of the member/ sponsor. All or part of your deposit will be kept if there is damage to the park or the cleanup was not done. All garbage must be placed in the garbage cans at the site. All tables, chairs, and equipment used for the party must be removed from the park after the party or stacked neatly for removal from the park early the next day. Our Association staff members are only responsible for emptying the garbage cans. All other cleanup work is to be done by or arranged to be done by the member/ sponsor.

Finally, there must be a single event Insurance policy in effect for the dates applied for naming Lake Tahoe Park Association as an additional insured with liability limits of at least \$1,000,000.00.
